### **Sub:- Position report by Sailing vessels to DG Commcentre as per Para 8 of D.1 of SOP for Indian Sailing Vessels 2018-reg..**

Reference to the above, in order to enhance security and safety measures it has been mandated by Para 8 of D.1 of SOP for Indian Sailing Vessels 2018  
**“Quote:-** Every Sailing vessel, when plying in International voyages will send a routine position report every 24 hours to its owners. The Owner of this sailing vessel would need to thereby forward this position report to the DG Comm. Centre who will in turn forward this report to the MOC (Delhi), Information Management and Analysis Centre (Gurgaon) and MRCC. **Unquote”.**

Further, all Owners/Masters/Agents of Ships/Vessels, doing international voyages are required to provide the position report as per the enclosed format for facilitating the case of data retrieval exchange.

Therefore all Owners/Masters/Agents of Ships, Barges, Passenger Launches, Tourist Boats, Operators of Mechanized/ Non – Mechanized Crafts, doing international voyages are hereby required to update the daily position reports by Sailing Vessel in the below google docs on daily basis:


