**Notification**

D-12018/6/COP

Whereas, the draft Rules, namely, the Goa Ports (Amendment) Rules, 2023 which the Government of Goa proposed to make in exercise of the powers conferred by section 6 read with sections 33, 34, 35, 39, 46 and 47 of the Indian Ports Act, 1908 (Central Act No. 15 of 1908), so as to further amend the Goa Ports Rules, 1983, were pre-published as required by sub-section (2) of section 6 of the said Act vide the Government Notification No. D-12018/6/COP dated 06-02-2023, of the Department of Inland Waterways, Captain of Ports, in the Official Gazette, Extraordinary No. 3, Series I No. 44 dated 07-02-2023, inviting objections and suggestions from all persons likely to be affected thereby within a period of 15 days from the date of publication of the said Notification in the Official Gazette;

And whereas, the said Gazette was made available to the public on 07-02-2023;

And whereas, the objections and suggestions received from public on the said draft Rules have been considered by the Government.

Now, therefore, in exercise of the powers conferred by section 6 read with sections 33, 34, 35, 39, 46 and 47 of the Indian Ports Act, 1908 (Central Act 15 of 1908), and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Ports (Amendment) Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Amendment of rule 54A.*— In rule 54A of the Goa Ports Rules, 1983, for sub-rule (1), the following sub-rule shall be substituted, namely:—

“(1) No Government riverine land shall be used for any purpose by any person without prior written permission of the Captain of Ports and without making advance payment of rental charges as specified in the Schedule below:—

Note 1: The rates of rental charges as specified in the above schedule shall be applicable for a period of twelve months from the date of issue of permission and thereafter such rental charges shall be paid at the rate increased by 10% of the rate of such charges last payable, after every twelve months.

Note 2: Once a new permission is issued for usage of riverine land, rental charges shall be paid in advance and even if the allotted space is not used, the amount paid shall not be refunded. Penalty at the rate of 5% shall be imposed for failure to renew permission before its expiry and for annual renewal of permission inspection fees of Rs. 1,000/- shall be charged. Also, for issue of new permission, inspection fees of Rs. 2,000/- shall be charged. For issue of new permission for repairs of riverine bund, fees of Rs. 10,000/- shall be charged.”.
